**GUN VIOLENCE**

**Four Days Left**, to help pass gun control legislation in this session!

- Don Harmon's **SB 337**, calling for the licensing of all Gun Dealers in the State of Illinois, has passed out of Senate and now awaits a vote in the Illinois House. *Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

- Under **Firearm Restraining Order SB2354**, a family member or police could petition a judge asking for an individual threatening gun violence to have their firearms removed (by Court Order) and held in protective custody. *Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

-**SB2343**, beginning 90 days after the effective date of the bill, prohibits the knowing sale, manufacture, purchase, possession, or carrying of a bump stock or trigger crank. *Final action deadline is May 31<sup>st</sup>! Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

**ONGOING - Institute for Non-Violence Chicago – 4926 W. **IMMIGRATION**

(Info from **Project IRENE**)

**Anti-Registry Program Act (SB 3488)**

This bill would bar state and local agencies in Illinois from creating or participating in any program that collects personal information to use to identify state residents based on their race, religion, national

origin, sexual orientation, or other characteristics. *Final Action deadline was extended to May 31<sup>st</sup>. Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

### **Safe Zones Bill (SB0035)**

This bill would direct the Illinois Attorney General to develop model policies for courthouses, schools, and medical facilities to limit interactions with Immigration and Customs Enforcement (ICE) agents if they appear at these facilities. *Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

### **VOICES Act (SB0034)**

VOICES would require law enforcement agencies to provide certifications (in most cases within 90 business days) for survivors of domestic violence, sexual assault, trafficking, and certain other offenses who need those certifications to get federal protection through U and T visas. Currently there is no requirement to provide the certification within a certain time, leaving many in limbo as they await a certification form. *Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

## **ENVIRONMENT/CARE OF THE EARTH**

(Info from the **Interfaith Green Network**)

**-SB2213**, "Illinois Baseline Protection Act" – maintains current Illinois safeguards, stops Federal rollbacks of environment and worker safety laws, and prevents the weakening of any current Illinois standard below the federal standard already in place. *Ask friends and family all across Illinois to **call** their state representative and urge them to **VOTE YES!***

**-HB5044 Clean Water** – "It is estimated that **1/8 of all lead service lines in the country are found here in Illinois**. This bill would require municipalities and private water utilities to replace all lead service lines in 10 years, with a focus on high priority areas and sound water infrastructure practices. In addition, this bill helps reduce the long-term costs of providing water service, by requiring proactive maintenance, repair, and replacement of system components like leaking pipes that are costing consumers substantial money throughout Illinois and establishes protections for low income water ratepayers." *Follow this bill **HERE**:*
